To the qualified electors of the CHARTER TOWNSHIP OF BLOOMFIELD, County of Oakland:

PLEASE TAKE NOTICE that any qualified elector of Bloomfield Township who is not already registered may register to vote at the Bloomfield Township Clerk’s Office, the office of the County Clerk, a Secretary of State branch office, or other designated state agency. Registration forms can be obtained at www.mi.gov/vote and mailed to the Township Clerk. Voters who are already registered may update their registration at www.expressSOS.com.

The last day to register in any manner other than in-person with the local clerk is **Monday, February 24, 2020**. After this date, anyone who qualifies as an elector may register to vote in person with proof of residency (MCL 168.497) at the Bloomfield Township Clerk’s Office, located at 4200 Telegraph, Bloomfield Hills, MI, 48302 at the following times:

- Regular business hours: Monday – Thursday from 7:00 a.m. to 5:30 p.m.
- Friday, March 6, 2020, from 10:00 a.m. to 5:00 p.m.
- Saturday, March 7, 2020, from 8:00 a.m. to 4:00 p.m.
- Election Day, Tuesday, March 10, 2020, from 7:00 a.m. to 8:00 p.m.

The election will be conducted in all voting precincts of the Charter Township of Bloomfield for the purpose of **nominating** candidates for the following office:
