

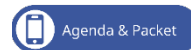


**NOTICE OF CONSIDERATION OF

PLEASE TAKE NOTICE THAT a public meeting will be held by the Board of Trustees of the Charter Township of Bloomfield, Oakland County, Michigan on **MONDAY, OCTOBER 14, 2024, at 7:00 p.m.**, in the auditorium at the Bloomfield Township Hall. Street address: 4200 Telegraph Road, Bloomfield Hills, MI 48302.

At the meeting, the Board will consider a site plan and special land use request for an indoor recreational restaurant use, Tee Times, to be located within the Maple Telegraph Shopping Center at 6565 Telegraph Rd. The request includes extended hours of operation to remain open until 12:00 am Monday-Saturday and until 11:00 pm on Sunday, and a Class C Liquor License.
