This report provides a summary of many arrests, incidents, events and other items of significance occurring in Bloomfield Township. However, it does not include every incident reported to the Police Department. It is possible for publicity to hinder some criminal investigations. In these situations, we do not release information unless it is in the community's best interest or we are certain it will not compromise an investigation.

#### Summary:

During the timeframe of December 16, 2024, through December 29, 2024, Bloomfield Township Officers handled 796 calls for service, 145 of which were traffic stops.

#### **Traffic Crashes:**

Officers investigated 77 total traffic crashes during this timeframe: 41 Property Damage Crashes, 8 Hit and Run Crashes, 7 Private Property Crashes, 3 Car vs. Deer Crash, 2 Non- UD-10, 1 Vehicle in Ditch and 1 Rollover.

### 24-24176 Unlawful Driving Away Automobile 5000 Block of Provincial Drive

On December 19, 2024, the Bloomfield Township Police Department took a report of the Unlawful Driving Away of Automobile. The victim stated her white 2024 Jeep Wrangler Sahara was parked in the circle driveway of her home, unlocked with the key fob inside, when it was stolen. Inside of the vehicle was a white Louis Vuitton purse, work laptop and black Gucci sunglasses. Stolen item estimated value, \$4400.00. On December 19,2024 the vehicle was recovered. ### **24-24190 Retail Fraud 3<sup>rd</sup> Degree** 1525 S. Opdyke Road

On December 18, the Bloomfield Township Police Department took a report for a Retail Fraud that occurred at 1525 S. Opdyke Road, Hollywood Markets. The manager stated the suspect entered the store and concealed Maxwell House Coffee, two Summers Eve products, Wing Dings and a Cobbler in her purse. The suspect is described as an older, heavy-set black female wearing a blue and white ringed

stocking hat, a heavy dark green jacket with a large light green purse. She left the store without paying for the items and fled in a white Ford Edge. Stolen item total: \$31.35. #### **24-24224 Retail Fraud 2<sup>nd</sup> Degree** 2141 S. Telegraph Road

On December 19, 2024, the Bloomfield Township Police Department responded to 2141 S. Telegraph Road, Bath and Body Works, for a Retail Fraud in progress. A witness saw two suspects filling baskets with merchandise inside of the store. The suspects ran out of the store without paying for the merchandise and fled in a white Chevrolet Impala, prior to officer's arrival. Suspect one is described as a short, chubby black female wearing an N-95 mask and a coat or fluffy sweater. Suspect two is described as a skinny black female wearing glasses. The suspects stole 21, 3-wick candles, and four gift boxes totaling \$681.75. This case was turned over to the Bloomfield Township Investigations unit and is currently under investigation.
